

support thereof, you are ordered to appear on 1/9/2008, 2008, at 8:30 , in


1 Department ___ of this Court located at 701 Ocean Street, Santa Cruz, California, 95060 to show

8 waste, setting open flame fires or other devices for preparing food with the use of fire, or ropes, and
9 enjoining all other persons with notice of the injunction from acting in concert or participating with
10 any of the aforementioned persons, or aiding or abetting any of the aforementioned persons in any of
11 the aforementioned conduct.

13 **IT IS FURTHER ORDERED THAT:**

14 This Order to Show Cause shall be served on defendants no later than
15 1/3, 200~~8~~ by personal service. Proof of such service shall be filed at least 2
16 court days prior to the hearing.

17 Any opposition papers to the Order to Show Cause shall be filed and
18 served on plaintiff by personal service no later than January 7, 2008. Any reply papers to the
19 opposition shall be filed and served on defendants by personal service no later than January 8,
20 2008.
