Dear Bus Charter Company:

The University of California Santa Cruz is developing a list of pre-qualified companies who provide Bus Charter Service for campus events. Campus departments can select from this list, which is accessible from the UCSC web-site. This process is meant to serve our campus departments with their requirements for this service and to ensure that all University of California requirements are met.

If you are interested in becoming a pre-qualified Bus Charter Vendor you must complete the enclosed application form and provide us with a current and correct Certificate of Insurance and Certifications. After your application has been reviewed and approved, your business will be added to the list of pre-qualified Bus Charter Vendors.

If you are interested in becoming an approved UCSC Bus Charter Vendor please complete the following steps:

1. Send a copy of your current Certificate of Insurance per the attached instructions (*be sure to have your agent name the UC Regents as additional insured*).
2. Send a copy of your current PUC Certificate
3. Complete the UCSC Bus Charter two- page application form.

Upon receipt of your completed application and documents listed above, your company will be reviewed. If your application is approved, your company will be added to the Pre-Approved Bus Charter Vendor List.

REQUIREMENTS FOR UCSC CAMPUS BUS CHARTER SERVICES
UNIVERSITY OF CALIFORNIA SANTA CRUZ

INSURANCE

The bus charter company providing charter services for campus events are required to show evidence of adequate insurance coverage by furnishing a certificate of insurance indicating compliance with all requirements stated below.

1. **The Bus Charter Company's general and auto liability insurance policies shall be endorsed to name the University as an additional insured.** The certificate must read as follows: "The Regents of the University of California, its officers, agents, and employees are named as insureds under the policy for all liability arising out of the provision of bus and transportation services by Bus Charter Company to University of California Santa Cruz," this policy shall be primary to any other valid and collectible insurance available to the Regents.
2. The **MINIMUM REQUIREMENTS** for bus charter companies are:
 - A. General Liability: Comprehensive or Commercial Form (preferred but not required).
 1. Each Occurrence \$1,000,000
 3. Personal and Advertising Injury \$1,000,000
 4. General Aggregate (not applicable to comprehensive form) \$2,000,000
 - B. Business Automobile Liability (MINIMUM LIMITS REQUIRED)\$5,000,000
 - C. Workers' Compensation as required under California State Law.

NOTE: To be approved by the University for charter of multiple buses for any one trip, the minimal required limit for Business Automobile Liability is \$100,000 per passenger.

3. Insurance company must provide thirty (30) days advance written notice to UCSC Purchasing, Tack House, 1156 High Street, Santa Cruz CA 95064 of any modification, change, or cancellation of any of the insurance coverage's.

PUC CERTIFICATE

The Bus Charter Company **must** provide a current copy of its PUC Certificate including the File TCP- number.

INDEMNIFICATION

The Bus Charter Company is required to provide the indemnification contained on page two of the application (Indemnification and Waiver).

APPLICATION

The Bus Charter Company must complete and sign all sections as required of the Application for UCSC Campus Bus Charter Service. The two page Application for UCSC Campus Bus Charter Service including all required certificates should be returned for review and approval to Diana Sue Miller, UCSC Central Purchasing, Barn G Tackhouse, 1156 High Street, Santa Cruz, CA 95064.

Company hereby agrees to defend, indemnify, and hold The Regents of the University of California, its officers, employees, and agents (University) harmless from and against any and all liability, loss, expense (including reasonable attorneys' fees), or claims for bodily injury, including death, or damages to property (including the loss of use thereof) arising out of the provision of bus transportation services to the University or the presence of Company employees or agents on the University's premises, and for any other injuries or damages except for such liability, loss, expense or claim which results from the sole negligence or willful misconduct of the University.
